Official Rules

No Purchase Necessary to Enter or Win

- 1. Overview.** Tenable, Inc. (“Tenable”) has created several promotional drawings where attendees at RSA® Conference will be eligible to participate in one or more drawings by completing the requirements for the applicable program. The programs are: (A) RSAC “Perks Pack” coupons; (B) attendance at a “Lightning Talk” at Tenable’s booth; and (C) participation in Tenable’s Spot-the-Bot social media campaign (collectively, the “Drawing”). Participants will also need to fill-out a submission form to confirm contact information. Participant names will be drawn randomly to be selected to win one or more of the prizes outlined below, based on the drawing(s) entered. The Drawing is sponsored by Tenable and begins on April 24, 2023, at 5:00 p.m. PT. Entries must be submitted during the Drawing Entry Period (as defined below) to Tenable in strict accordance with Tenable’s instructions and these Official Rules. Entrants are limited to a single entry during the Drawing Period. Those who do not abide by these Official Rules or Tenable’s instructions or the prize fulfillment requirements may be disqualified at Tenable’s sole discretion. Tenable may keep all Entrant information after completion of the Drawing for business management and record keeping purposes.
- 2. Eligibility.** The Drawing is open only to all individuals who are 18 years of age or older; however, (a) employees of Tenable and/or the immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee, and (b) public officials (including federal and state government employees) are not eligible to win the prizes described herein. No purchase of Tenable’s products or services is necessary to participate in the Drawing. All U.S., federal, state and local laws and regulations apply and this Drawing is void where prohibited by law.
- 3. Sponsor.** The sponsor and administrator of this Drawing is Tenable, Inc., with its place of business located at 6100 Merriweather Drive, Columbia, MD 21044, United States of America. The Drawing is no way sponsored, endorsed, or in association with RSA, Twitter, LinkedIn, Meta or their affiliates. Each Entrant completely releases and absolves RSA, Twitter, LinkedIn, Meta and/or their affiliate from any association or liability of this Drawing. - 4. Agreement to Official Rules.** Participation in the Drawing constitutes Entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein. By accepting a prize, winners represent that they are permitted, by applicable law, regulation, and their relevant employment policies, to accept the prize.

5. **Drawing Entry Period.** The Drawing begins on April 24, 2023 at 5:00 p.m. PT and ends on April 27, 2023 at 3:00 p.m. PT (the “Drawing Entry Period”).
6. **Entry.** To enter the Drawing, eligible entrants must complete one of the following, depending upon the program:
 - (A) RSAC “Perks Pack.” The RSAC Perks Pack, included with “Full Conference” pass types, includes a special coupon book. RSA attendees can enter this drawing by tearing out the coupon portion of the advertisement and bringing it to the Tenable booth. Each coupon collected will be worth one entry in the corresponding drawing.
 - (B) “Lightning Talks.” Tenable subject matter experts will give short (approximately 10 minute) presentations in the Tenable booth during high-traffic booth periods. Each Lightning Talk attendee will receive (1) entry ticket for the corresponding drawing.
 - (C) Spot-the-Bot. To qualify for an entry in this drawing, an RSA attendee must post a photo, which includes Tenable’s bot sticker, on a social media platform, tag an official Tenable account (Twitter: @TenableSecurity; LinkedIn: @Tenable; and Instagram: @lifeattenable), and use the #SpotTheBot hashtag.
7. **Winners.** The winners will be selected by randomly drawing a ticket from a bucket of all entry tickets during the Drawing Entry Period. Drawings will occur as follows for each program:
 - (A) RSAC “Perks Pack” drawings. Each coupon collected at the Tenable booth will go into a raffle to be randomly drawn on Wednesday, April 26th at 6 p.m. PT (when the show floor closes).
 - (B) “Lightning Talks” drawings. At the conclusion of each Lightning Talk, Tenable shall conduct a random drawing of entrants gathered at that Lightning Talk. Tenable will immediately announce the winning ticket. If the owner of the winning ticket is not present at the time of the drawing, another ticket will be drawn. This will happen until a ticket is drawn whose owner is present at Tenable’s booth at the time of the drawing.
 - (C) Spot-the-Bot drawings. Tenable will conduct a random drawing of qualified entrants and select two winners each day.

If a potential winner did not comply with the Official Rules of this Drawing, their entry will be void and Tenable will perform another random drawing to select an alternate winner in his/her place. Eligible participants may win one prize per program, but may not win more than one prize per program.

8. **Prizes.** There will be different prizes for each program.
 - (A) RSAC “Perks Pack” prize. There will be one (1) Perks Pass prize, a \$1,000 gift card to Recreational Equipment, Inc., doing business as “REI”.

- (B) “Lightning Talks” prizes. There will be one (1) winner per each of the 29 Lightning Talks, for a total of 29 prizes. At the end of the Lightning Talk, the speaker/presenter will draw one (1) winning ticket at random to win one (1) of a selection of prizes. To determine prize, the owner of the winning ticket will draw from a deck of cards where each card is labeled with one (1) prize. The prize listed on the card the winner pulls will be the prize they win. The available prizes are:
- a. 4 x \$250 REI gift card
 - b. 10 x \$100 Amazon gift card
 - c. 4 x \$25 Starbucks gift card
 - d. 4 x Beats Studio headphones (valued at \$150 each)
 - e. 4 x Apple AirPods (valued at \$250 each)
 - f. 6 x Apple Watch SE (valued at \$280 each)
 - g. 4 x Tenable branded travel mug (valued at \$20)
- (C) Spot-the-Bot prizes. There will be a total of eight (8) \$50 Amazon gift cards awarded (two (2) per day for each of the four (4) days of the conference).

Tenable will notify the potential winners differently, depending upon the applicable program. For the (A) RSAC “Perks Pack” prize, we will notify the winner before 10 a.m. PT on April 27, 2023 and the winner must pick up their prize before 3 p.m. PT on April 27, 2023; for (B) “Lightning Talks,” winners will be announced at the conclusion of each talk and the winner must be present at the time of drawing to select a prize; and for (C) Spot-the-Bot, Tenable will notify the winners before 10 a.m. on April 27, 2023 and the winner must pick up the prize before 3 p.m. PT on April 27, 2023. . If a potential winner does not collect their prize in accordance with these terms, Tenable shall choose an alternate winner or the prize will be forfeit, at Tenable’s discretion.
